Agreement between User and Thoughtbubblez.org

Welcome to Thoughtbubblez.org. The Thoughtbubblez.org website (the "Site") is comprised of various web pages operated by Thought Bubblez, Inc. ("TBz"). Thoughtbubblez.org is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms"). Your use of Thoughtbubblez.org constitutes your agreement to all such Terms. Please read these terms carefully, and keep a copy of them for your reference.

Privacy

We adhere to the Children's Online Privacy Protection Act (COPPA) in our data collection practices for children:

- Parent's email address: We use this to obtain verifiable parental consent, provide important updates, and communicate about account-related matters.
- Parent's phone number: This allows us to contact parents directly if necessary, such as for urgent matters or to verify consent.

We provide information about our personal data practices for children on our home page and wherever we knowingly collect personal data from children on our Web site. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website. Cancellation/Refund Policy

At Thought Bubblez, we understand that life happens! We strive to be fair to both our families and our independent instructors. Please review our cancellation policy below:

Workshops & Classes

Participant Workshop & Class Cancellations:

7+ days notice: Full refund or credit toward a future class.

3–6 days notice: 50% refund or credit.

Less than 72 hours: No refund or credit (due to planning, materials, and instructor commitments).

No-shows: No refund or credit.

Thought Bubblez Workshop & Class Cancellations:

If Thought Bubblez or the instructor must cancel a class or workshop, participants will be offered a full refund or a rescheduled opportunity.

We reserve the right to cancel a class due to low enrollment, instructor illness, or unforeseen circumstances.

Tutoring Sessions

Student Tutoring Cancellations:

24+ hours notice: No charge; session may be rescheduled or canceled.

Less than 24 hours: Full session fee will apply. No refund or reschedule.

No-shows: Full session fee will apply.

Tutor Cancellations:

Tutors (as independent contractors) are expected to give at least 24 hours notice when canceling a session.

In the event of a tutor cancellation, the session will be rescheduled at no additional cost, or an alternative tutor may fill in, depending on availability and student preference.

General Notes

Independent instructors are contracted by Thought Bubblez and set their own availability. We strive to align policies for consistency, but please note that some instructors may have additional requirements specific to their offerings.

Each event, class, or workshop may have a unique cancellation policy. Please carefully review the specific cancellation terms provided at the time of booking or purchasing tickets.

Refunds will be processed within 7–10 business days if applicable.

The arbitrator's award shall be final, and judgment may be entered upon it in any court having jurisdiction. In the event that any legal or equitable action, proceeding or arbitration arises out of or concerns these Terms and Conditions, the prevailing party shall be entitled to recover its costs and reasonable attorney's fees. The parties agree to arbitrate all disputes and claims in regards to these Terms and Conditions or any disputes arising as a result of these Terms and Conditions, whether directly or indirectly, including Tort claims that are a result of these Terms and Conditions. The parties agree that the Federal Arbitration Act governs the interpretation and enforcement of this provision. The entire dispute, including the scope and enforceability of this arbitration provision shall be determined by the Arbitrator. This arbitration provision shall survive the termination of these Terms and Conditions.

Class Action Waiver

Any arbitration under these Terms and Conditions will take place on an individual basis; class arbitrations and class/representative/collective actions are not permitted. THE PARTIES AGREE THAT A PARTY MAY BRING CLAIMS AGAINST THE OTHER ONLY IN EACH'S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PUTATIVE CLASS, COLLECTIVE AND/ OR REPRESENTATIVE PROCEEDING, SUCH AS IN THE FORM OF A PRIVATE ATTORNEY GENERAL ACTION AGAINST THE OTHER. Further, unless both you and TBz agree otherwise, the arbitrator may not consolidate more than one person's claims, and may not otherwise preside over any form of a representative or class proceeding.
